Minutes meeting September 2014 – posted on the web – no corrections – minutes stand as posted.

Treasurer's report – we have about \$92,000 in our checking account. Our annual budget is about \$90,000. Our goal is to have the funds to operate until we receive income from our championship meets. That is our only source of income. We have to pay for awards, rentals and others before that money comes in.

Expenditures approved by Executive Committee (do not need vote from general body)

\$400 to purchase a table at Jose Cerde Banquet in June 2016

\$250 room rental for official's clinic

Meredith explained her role – the role of regional representatives and group official representatives. In addition she went over branding compliance. Every YMCA must be compliant by the end of 2015.

Regional representative – - Bill Whatley – Bill explained the importance of registering every coach on the national web site. Registration is not just for nationals. Every coach that stands on deck for practice or meets MUST register on the website. The coach needs to upload his credentials as he registers.

Time standards – Bill Whatley – explained how time standards are set. This is our method of controlling the size of the AA Meet. All time standards posted on the web.

TrueSport – Mickey McNeil- The league has paid for all of our coaches to become TrueSport Coach. The process only takes 3 hours or so. TrueSport has a wealth of information available to coaches. In 2015 we realized that we were in violation of Rules that Govern YMCA Sports. The addendum states that the collegiate swimmer may participate but must be exhibition. They can evens swim in finals but must be exhibition.
